

Padres Ticket Giveaway

North County Transit District, operating as North County Transit – San Diego Railroad (NCTD), is hosting a sweepstakes (“Sweepstakes” or “Contest”) to offer individuals the chance to win 2 or 4 San Diego Padres baseball tickets to 9 separate games (“Padres Ticket” or “Prize”). The Padres Tickets will be given out via a random drawing 2 days prior to each of the 9 games. NCTD will use a random drawing app to choose the winner of the tickets.

The Prize is subject to availability, applicable ticket terms, venue rules, and game-date, time, opponent, and schedule changes. Parking, transportation, food, beverages, merchandise, and all other expenses are not included unless expressly stated.

The random drawing contest (“Sweepstakes” or “Contest”) will run from May 14, 2026 – September 26, 2026 (“Sweepstakes Period”).

HOW TO ENTER: Contestants must follow GoNCTD on Instagram, Facebook or X, formerly Twitter, and enter to win by following the instructions in the Padres Ticket drawing post on these social media platforms and “like” the post and comment on the post to be entered to win the tickets, or they may enter to win by emailing marketing@nctd.com, which will be shared on the GoNCTD.com/Padres web page. All eligible entries, regardless of entry method, will have an equal chance of winning. All entries must be submitted by 11:59 p.m. (PT) 3 days prior to each of the 9 Padres games. The dates of those 9 games will be provided in social media posts and via the GoNCTD.com/Padres web page. Limit one (1) entry per person per game, regardless of method of entry, email address, social media account, or platform.

NCTD will include a web link to the contest disclaimers on the GoNCTD.com/Padres web page.

HOW WINNER IS CHOSEN: A random drawing will take place 2 days before each of the 9 games. Winners have 24 hours to respond either on social media or via email once notified that they won the prize. If a response is not received from the winner in 24 hours, another random drawing will take place. Electronic tickets will be sent via the Major League Baseball App (“MLB App”). Contest winners must download the

MLB App to receive the tickets and provide the email address connected to the MLB App to receive the tickets.

DISCLAIMERS FOR A PROMOTIONAL GIVEAWAY:

NO PURCHASE NECESSARY. No purchase is necessary to enter or win. A purchase does not increase the chances of winning.

ODDS: The odds of winning depend on the number of eligible entries received.

SWEEPSTAKES OR CONTEST ENTRY INSTRUCTIONS: During the Sweepstakes Period, you may submit one entry, and one entry only for each of the 9 games. One submission per game for a maximum total of entries of 9.

PRIZE: The electronic Padres Tickets will be sent via the MLB App, which can be downloaded for free from the Apple App Store or Google Play. Contest winners must download the MLB App prior to receiving the electronic tickets and provide NCTD the email address attached to the app. Prizes are not transferable and are not redeemable for cash. Any and all prize related expenses, including without limitation any and all federal, state, and/or local taxes, shall be the sole responsibility of the winner.
